

CHANGING YOUR ADDRESS IS A CRUCIAL PART OF SEVERING THE CONTRACT!

You might think this isn't very important but anything and everything you can do to avoid contracting with the corporate entity known as THE UNITED STATES OF AMERICA is what you should be doing if you want to be free – really free.

I was watching a video from Taquan Williams which was only 2 minutes or so, thanks to Judy B. The video said how he had changed his address and – after being convicted of at least one felony, he has been separated from the “system” and his troubles are not only fixable, some have disappeared. It's a real blessing for him and his family.

Judy showed me her own Driver's License card which she had gotten with the instructions from Taquan and it showed RFD, Non-Domestic. That was awesome.

Taquan said you might be able to do this online, so after a minute of research, I located my Department of Revenue Driver's License bureau and changed my address. It literally took about 5 minutes.

They asked for my name and Social Security number so they could look up my record. Up popped the form and the record and I started the process. When it asked for my old address, I used the one on the card. Then on the new address where it asked for the number/street address, I typed in RURAL FREE DELIVERY. No numbers, nothing just that.

The next area was CITY and I typed in NON-DOMESTIC, that took.

The next was the State which of course is where you live in the Republic. I checked Missouri.

Then came the area that usually gives everyone a huge headache. The ZIP CODE. I typed in 00000 and hit enter. It worked!

I clicked the submit button and the next thing it asked for was the old address. I input what was on the current document and boom! Took that too.

Then there was the next screen which I thought was odd. It asked me for the registration on any vehicles/property I had in order to change that too.

As you may know, the DMV never gave me my plate after paying \$1275 for a plate that said “QPLUS” and its still out there somewhere so I will most likely just make my own with that on it and they can look it up.

At first I was panicking because I forgot that I had that vanity plate – this speaks volumes for having a vanity plate I can tell you! It was asking for the plate number, I typed that in and BOOM! That came up too.

I thought since they couldn't locate my plate, there might be an issue but now that I know that's the actual plate number, I did the same thing and put the address as RURAL FREE DELIVERY, NON-DOMESTIC, MISSOURI, 00000 and that took also. Now, if I want to just get a plate made since they can't seem to locate the one I had, a militarized uniformed policy enforcer could actually run that and

get something which should say, DO NOT ARREST DO NOT DETAIN.

Now, the contract is severed and I have nothing as far as an address established with the DMV which is how they're pulling us into the court system. It's all about the contract and putting the address to the Social Security number.

No address – no contract. No contract, no jurisdiction.

I like that.

But what about mail?

I'm glad you asked.

Don't call your dwelling location "address" anymore! Here's the legal definition of address from Black's Law Dictionary - the official legal dictionary of the United States Supreme Court:

ADDRESS: That part of a bill in equity wherein is given the appropriate and technical description of the court in which the bill is filed.

What is the meaning of "bill in equity"?

Bill in Equity: A legal process whereby a party to a contract institutes an action asking for equitable relief.

What's the difference between the Post Office and the Postal Service?

POSTAL SERVICE: Independent agency charged with processing and delivering mail and with protecting the mail from loss, theft, or abuse in accordance with U.S. postal laws.

POST OFFICE: A bureau or department of government, or under governmental superintendence, whose office is to receive, transmit, and deliver letters, papers, and other mail-matter sent by post.

It's all about the contract, baby!

Without the contract, they have nothing.

So you need to write your envelopes with the following:

**April-LaJune: McGill
non-assumpsit/TDC:
c/o 123 Main Street,
Independence, Missouri [64050]
Republic of the united States of America
Republic of Missouri**

Assumpsit: In common law, an action to recover damages for breach of contract.

Non-Assumpsit: The general issue in the action of assumpsit; being a plea by which the defendant

avers that "he did not undertake" or promise as alleged.

*TDC means: **Threat, Duress or Coercion** indicating you're not signing a contract and there is a special delivery for this type of mail so you can't be pulled into the court system. Total Delivery Cost/Terms of Delivery/Type of Delivery Contract – meaning they can't make a contract with you.*

Since you're not admitting to being a “defendant” in a bill of equity to drag you into court when you write “c/o” which means “in care of” in lower case letters. Not in upper case. There is a difference because you want to remain part of the Republic, not the CORPORATION.

The Post Office employees ignore things because they are clueless. Don't worry about getting your mail. They will deliver it.

Brackets around the zip code are legally saying “these inner contents are legally isolated from and not to be construed as part of the legal meaning of the surrounding content.”

Obviously, Republic means you are part of the land, not the CORPORATION.

This keeps you out of the contract and outside of the jurisdiction of the CORPORATION.

You will need to look through everything you have and determine what other contracts you may have.

I know it is necessary to have mail brought to you so you don't have to continually retrieve it.

If you have to hand write to companies to change the way they are sending you items, you may have to provide them with a letter, an email or handwrite out the form. I would suggest calling whatever company you're dealing with and ask them how they'd like to handle the change for you. Insist. You must insist. You don't need to explain anything to them. Just tell them it's a legal matter and leave it at that. Once you invoke “it's a legal matter” the other person usually doesn't know how to respond and they'll drop it.
